### ***Disciplinary Information***

In February 2011, April Spittle plead guilty to making and aiding and abetting illegal campaign contributions in 2007 to the campaign of a presidential/senate candidate in the names of others in violation of Title 2, Unites States Codes Section 441(f) and Tile 18, United States Code, Section 2. Mrs. Spittle plead guilty to using her name and credit card to make a campaign contribution, which contribution was reimbursed to her by a corporate entity, participated in raising contributions by a corporation in the names of others to candidate's campaigns as well as delivering reimbursements for such contributions and, participated in backdating letters attempting to disguise such reimbursements. Mrs. Spittle was sentenced to one year unsupervised probation and ordered to pay a fine of \$5,000 and a \$25 special assessment fee.

### ***Other Business Activities***

Ms. Blake is the owner of Beach & Associates Financial Services. Ms. Blake receives compensation for these activities above and beyond the fees earned as advisor for Interactive Financial Advisors. The fees you pay our firm for advisory services are separate and distinct from any compensation Ms. Blake earns for employment at Beach Financial and Insurance Professionals.

April Blake is a registered representative with Fortune Financial Services, Inc. Fortune Financial Services, Inc. is a diversified financial services company engaged in the sale of specialized investment products.
